1. **Meeting riders** between 8 am & 9am on Fri 12<sup>th</sup>/Sat 13<sup>th</sup> at Echunga Trail Head for equip. transfer
2. **Reserve one horse yard** per booking. Maximum of 8 bookings per shift
3. **Reserve one bed** per booking in Woodcutter’s cottage, per shift
4. **Provide a hot meal** at 6.30 pm at Woodcutter’s cottage on Friday & Saturday nights.
5. **Set up a campfire** for sharing your trail experiences around on Friday & Saturday nights.
6. **Provide breakfast** at 7 am at Woodcutter’s cottage on Friday & Saturday morning.
7. **Provide morning tea & Lunch** for those who book for a “double shift”

### **On payment of the Registration fee, Horse SA will provide you with:**

- **Receipt** and confirmation of booking
- **Initial contact** - to discuss how you would like to manage transfers/equipment or other questions.
- **A link up** with other riders who may also be looking for someone to ride with
- **Forest maps** and any purchased **Kidman Trail maps**
- Providing a copy of the **Adventure Activity Standards, Code of Practice for Horse Riding** and other items of interest on registration.
- Your **Forestry SA horse riding permit** (this will arrive prior to the event, or be available for pick up on the day according to timing of payments)
- A suggested **check list** of items to bring along

### **General Conditions**

**Please note:** Horse SA is not conducting or organizing a trail ride, caring for or transporting horses, only transport of equipment (not driving floats) transfers from Forest Gate Lodge and meals are supplied. Horse SA has dual booked the Jack's Paddock horse yard facility & Woodcutter's cottage to enable newcomers to long distance riding to experience a day ride and bunk bed-dormitory room style accommodation without having to take a pack horse or back up vehicle.

- All participants must be over 18 yrs.
- No dogs
- Riders to carry mobile phones & personal first aid kit.
- Riders to register their anticipated ride time/route with Horse SA
- All riders must provide evidence of personal accident insurance & public liability insurance that covers you for horse riding on public land.
- All horse owners are strongly recommended to ensure that each horse is covered with Public Liability insurance that covers the horse for ridden activities off the home property
- No stallions or Rigs
- All horses to be fit for the intended riding distance, shod or wearing hoof boots, and showing no signs of infectious skin conditions, nasal discharge, coughing, lameness or other illness. Horses may be asked to leave if unwell. Horse welfare is paramount.
- No drugs
- Disorderly horses or persons will be asked to leave.

(Many insurance companies advertise in "Horse Deals" magazine each month or you may be covered under a club or association of which you may already be a member.)

### **Cancellation Policy**

- Cancellations made within 48hrs will have all fees, minus an administration fee of \$15 returned.
- Cancelled riders may replace their position with another rider with no penalty. A new application form must be completed by the new rider taking your position.

### **Communication**

Please do not hesitate to ask any questions prior to attending the weekend, as this is part of helping you enjoy your ride. You may, for example, wish to start or finish riding at a different point and want to arrange equipment drop off at the yards at a different time.

Please advise us if you are looking for someone to potentially ride with, and we can circulate your contact details to others who have registered.

Please note that any information provided is a guide only and you will need to evaluate, adapt or modify it according to your experience level and needs.

## Horse SA Event Participation Declaration

1. **"Horse SA"** for the purposes of this application and declaration means The Horse Federation of South Australia Incorporated, its members and where the context so permits, their respective directors, officers, members servants or agents.

2. **If accepted I will be permitted** to participate in this event subject to my complying with these terms and conditions and any reasonable direction issued by Horse SA.

3. **This document cannot be amended.** If I do amend it my application to participate will be null and void.

4. Horse SA is conducting a **supporting food and accommodation event** on this date. ***Horse SA is in no way connected with the actual riding, transporting or keeping of horses in this event. The intention of Horse SA is to provide support backup by way of providing meals, organising accommodation of people and horses, and carrying of equipment only. Horse SA is not involved in the actual riding or care of horses in any way.***

**Warning:** Riding & handling horses can be inherently dangerous. Serious accidents can and often do happen which may result in persons being injured or even killed. By signing this, you agree that you have voluntarily read and understood this warning and accept and assume the inherent risks in the attending the event, where horses may be present.

5. **Exclusion of Liability:** Except where provided or required by law and such cannot be excluded, I agree that it is a term of my participation in the event that Horse SA is absolved from all liability however arising from injury or damage however caused (whether fatal or otherwise) arising out of my participation in this event. I acknowledge that the services and benefits I receive in relation to this event are "recreational services" as defined under the *Trade Practices Act 1974*. Where I am a consumer, as defined by any relevant law, certain terms and rights may be implied into a contract for the supply of goods or services for my benefit. I acknowledge that these terms and rights, and any liability of Horse SA flowing from them, are expressly excluded, restricted or modified by these terms and conditions.

6. **Release and Indemnity:** In consideration of Horse SA accepting my participation in this event, I:

- (a) release and forever discharge Horse SA from all Claims that I may have or may have had but for this release arising from or in connection with my participation in this event; and
- (b) indemnify and hold harmless Horse SA to the extent permitted by law in respect of any Claim by any person including but not only another participant arising as a result of or in connection with my participation in this event.

In this **clause "Claims"** means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising but does not include a claim in respect of any action, suit, etc made by any person entitled to make a claim under a relevant HSA insurance policy.

7. **Medical Treatment:** I consent to receiving any medical treatment that Horse SA considers necessary or desirable during or after the event. I also agree to reimburse Horse SA for any cost or expenses incurred in providing me with medical treatment.

8. **Privacy:** I understand that the information I have provided on the event application form is necessary for the conduct of the event and for the objects of Horse SA. I acknowledge and agree that the information will only be used by Horse SA to facilitate the conduct of the event.

9. **Copyright in photographs and right to use:** I acknowledge and consent to photographs being taken of me during my participation in the event.
